| 9 | SAFA inspections – EASA projects

EASA are currently working on two SAFA related projects which will be of interest to ERA members: system-wide coordination – the system to co-ordinate the number of inspections for the 200 most active commercial operators flying in EASA airspace, in order to prevent the over and under inspection of those operators; and manufacturer data – the inspection guidance developed to reduce the number of category 3 findings based on manufacturer limits by shifting the responsibility to assess the defects from the inspector to the operator. | |
| 10 | The Loganair experience with PBN & LPV
Stewart Houston – Manager Flight Support, Loganair
Loganair operates a diverse fleet consisting of five types ranging from the nine-seat Britten-Norman Islander to the 50-seat SAAB2000. Until March of this year, none of the flight crew were PBN-qualified and only three aeroplanes were equipped for LPV approaches. This is despite the proximity of the 25 August PBN deadline, airfields around the Scottish route network being well provided with GNSS RNAV approaches, and a programme of removal and replacement of terrestrial aids with limited mitigation other than the GNSS approaches. This talk describes how Loganair approached these challenges and the company's current position regarding aircrew qualification and aircraft equipage. | |
